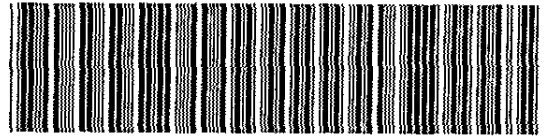

ARTICLES OF INCORPORATION OF
Operation Help Outreach Global Ministries Inc.

The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation not for profit under the laws of Florida.

ARTICLE I

NAME

The name of this corporation is **Operation Help Outreach Global Ministries Inc.**

ARTICLE II

PRINCIPLE OFFICE

The principle place of business and mailing address of the corporation shall be: 7880 Lancia Street, Jacksonville, Florida 32244

ARTICLE III

PURPOSES

This corporation is organized exclusively for charitable, educational, religious or scientific purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code (or corresponding section of any future Federal tax codes).

This corporation is organized and operated exclusively for non-profit purposes and no part of any net earnings shall inure to the benefit of any member, director or officer.

Notwithstanding any other provision of the Articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under Section 501 (c)(3) of the Internal Revenue Code (or corresponding section of any future Federal tax code) or (b) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code (or corresponding section of any future tax code).

Nature of Business

The general nature of the ministries is to provide a full range of services designed to promote healthy and productive lives. This shall include but shall not be limited to:

1. A training and educational program for ministers.
2. Pre-school care and education for pre-schoolers.
3. K-3 through 12th grade school.
4. A radio ministry.
5. A television ministry.
6. Printing, publishing and distributing pamphlets and books.
7. The duplication and distribution of audio and videotapes.
8. To provide care for the homeless and abused children, senior citizens, and adults.
9. To provide the following services: Shelter, Mental Health programs, Substance Abuse Counseling, Job Training, Education Enrichment Program, Senior Citizen Care, Childcare, Tutorial Program, and Economic Empowerment.
10. To furnish the basic tools needed to acquire jobs and home: Basic Skill Training, GED Program (English and Math), Job Training, Job Placement, Financial Counseling, Debt Consolidation, Money Management, Educational Assistance, Parenting Classes, College Placement, and Assistance Securing Permanent Housing and loans.
11. To assist Health Care Agency by providing Basic Medical Treatment, Drug/Alcohol and Mental Health Counseling.
12. To Sponsor Neighborhood Improvement Programs and restore neighborhoods
13. To establish foreign missions in third world countries of Africa, Asia, West Indies and Central and South America.

The ministry shall be authorized and directed by the **Operation Help Outreach Global Ministries Inc.**, Jacksonville, Florida, hereinafter known as said body; and to do any and all other business, acts, and things as may be allowed under the laws of Florida and authorized by said body according to the Constitution and Bylaws of the body.

ARTICLE IV

TERM OF EXISTENCE

The term for which this corporation shall exist shall be perpetual.

ARTICLE V

MEMBERSHIP

The qualification of members of this corporation shall be that they each are members in good standing of and in the unincorporated body of **Operation Help Outreach Global Ministries Inc.** New members of this corporation shall be admitted only through membership in said unincorporated body as specified in the Constitution and Bylaws. Membership in this corporation and in said unincorporated body shall be identical. The Constitution and Bylaws will provide details of election to the Board of Director and the membership rights and privileges and duties of members, associates and other such classes as may from time to time be established.

ARTICLE VI

MANAGEMENT OF CORPORATE AFFAIRS

The powers of this corporation shall be exercised, its properties controlled, and its affairs conducted by a board of four (4) to nine (9) directors as determined by the unincorporated body of **Operation Help Outreach Global Ministries Inc.** as specified in its Constitution and Bylaws. The manner of election or appointment of directors, their terms of office, and all other provisions regarding the regulations of the affairs of the corporation shall be set forth in the Bylaws.

BOARD OF DIRECTORS

The initial Board of Directors, whose members are to serve until successor or additional members of the Board of directors are elected or appoint pursuant to the bylaws, shall consist of the following directors whose names and addresses are:

ARTICLE IX

BYLAWS

The Constitution and Bylaws of this corporation shall be identical and the same as the Constitution and Bylaws made, amended, altered and rescinded by the members in good standing of said unincorporated body. Any amendments to the Constitution and Bylaws shall be binding on all members of this corporation.

All officers, directors, and agents of this corporation shall be elected, recalled, replaced, instructed and controlled in any business or matter relating to the affairs of this corporation in accordance with the terms of the Constitution and Bylaws of the unincorporated body of Operation Help Outreach Global Ministry Inc. It is required that the unincorporated body mentioned in this charter shall believe in and subscribe to the Articles of Faith and the Article of Doctrine as prescribed in the Constitution of said body. The unincorporated body mentioned in this charter shall subscribe to the faith and doctrine of the Operation Help Outreach Global Ministry Inc.

ARTICLE X

AMENDMENTS OF ARTICLE

Amendments to these Articles of Incorporation may be proposed and adopted by members in good standing in said unincorporated body, at a business meeting called in accordance with the Constitution of this body. A two-thirds (2/3) majority of members in good standing, attending and voting at the specified business meeting shall constitute approval, subject to the approval of the Secretary of the State of Florida, as required by law.

ARTICLE XI

DISSOLUTION

Upon dissolution or winding up of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of the corporation shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for religious purposes and which has established its tax exempt status under Section 501(c)(3) of

the Internal Revenue Code of 1954, or corresponding provisions of any subsequent federal tax laws.
