the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit-Corporation under the Non-Profit Corporation Law of Florida, do hereby certify:

## ARTICLE I

The name of the corporation shall be:

The purposes of this corporation are:

Notwithstanding any other provision of this document, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in futherance of the purposes of this corporation.
