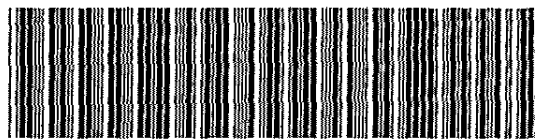

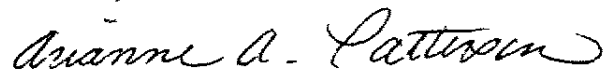
Dear Division of Corporations,
