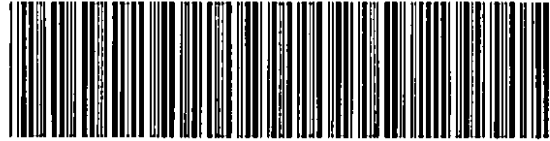

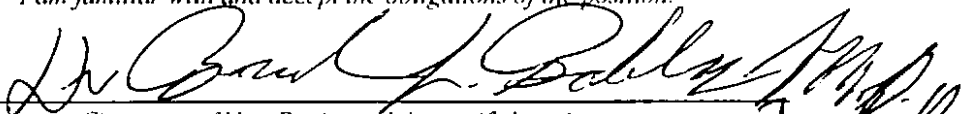

I am the new Chairman of Kissimmee Family Mission, Inc. as of March 2019. The Corporation was amended in April 2019 by Cynthia Perez Rodriguez without the permission of the Co-Founder Nellie Perez, as the other Co-Founder Raphael Perez deceased in March 2019. I was the Market Manager at Kissimmee Family Mission, Inc. and the Master Treasurer at Kissimmee Family Mission, Inc. On February 06, 2016, Nellie Perez stated that if anything were to happen God forbid, that Kissimmee Family Mission, Inc. would be given to me, Kissimmee Family Mission, Inc. "KFM" (Represented by Nellie Perez) & Boldes Brandon Foundation, Inc. "BBF" (Represented by Brandon Boldes) made into effect an organizational partnership for a lifetime. The conversation of taking over KFM was again brought up on April 30, 2016, in November 2017, in January 2018 and January 2019. The non-profit corporation dissolution rules and regulations states that because of the of the partnership of BBF and KFM, another nonprofit takes over the nonprofit going into dissolution. Please note BBF will and has taken the name of KFM to satisfy section 501C)(3) or 170 (C)(2) of the Internal Revenue Code, 1986 or the corresponding provisions of any future federal law. On September 11, 2019, Nellie Perez verbally gifted Kissimmee Family Mission, Inc. On September 20th 2019, I discovered that in April 2019, the name of Kissimmee Family Mission, Inc was changed to Kyrios Rapha Mission, Inc.. I learned from Nellie Perez that she stole the ministry and forced her to resign and retire. Cynthia "Cindy" Perez needs to get her own 501(c)(3) and register Kyrios Rapha Mission, Inc. separately with Sunbiz, and close all bank accounts that has Kissimmee Family Mission, Inc.. linked to Kyrios Rapha Mission, Inc.
