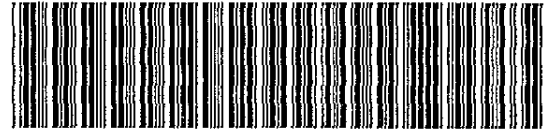

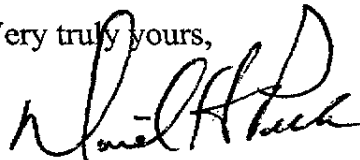

**ARTICLES OF AMENDMENT TO
ARTICLES OF INCORPORATION OF
FIRST COAST ONCOLOGY FOUNDATION, INC.
(a non-profit corporation)**

The following provisions of the Articles of Incorporation of First Coast Oncology Foundation, Inc., a Florida non-profit corporation ("Corporation") are hereby amended in the following particulars:

1. The name of this Corporation is First Coast Oncology Foundation, Inc.
2. An amendment to Article I of the Articles of Incorporation has been adopted by the Board of Trustees of the Corporation to change its name. As amended, Article I now reads as follows:

ARTICLE I

Name and Place of Business

Section 1.1 Name and Place of Business. The name of this corporation is FIRST COAST CANCER FOUNDATION, INC., with its principal place of business at 2501 Riverside Avenue, Jacksonville, Florida, 32205.

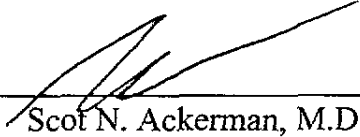
3. There are no members entitled to vote on the amendment.
