ARTICLES OF AMENDMENT OF THE ARTICLES OF INCORPORATION OF AMHERST VILLAGE PROPERTY OWNERS ASSOCIATION, INC.

Pursuant to the provisions of Fla. Stat. 607.1006, the undersigned corporation adopts the following Articles of Amendment of its Articles of Incorporation:

1. Article X of the Articles of Incorporation is hereby amended and restated, as follows:

ARTICLE X

NUMBER OF DIRECTORS

The business of this Corporation shall be conducted by a Board of Directors which shall consist of not more than five (5) persons. Effective January 1, 2020, the Board shall consist of two (2) members from Bellamy Ridge, two (2) members from Hunt Club, and one (1) member from Foxfire. The names and addresses of the original Directors shall be:

The Directors of the Corporation shall be elected at the annual meeting of the Members, as specified in the By-Laws. The election of Directors shall be by majority vote.

Board of Director One will be elected at the annual meeting in March of 2020 and will be held by an individual from Bellamy Ridge for two (2) years. Board of Director Two will be elected at the annual meeting in March of 2020 and will be held by an individual from Bellamy Ridge for one (1) year. Board of Director Three will be elected at the annual meeting in March of 2020 and will be held by an individual from Hunt Club for two (2) years. Board of Director Four will be elected at the annual meeting in March of 2020 and will be held by an individual from Hunt Club for one (1) year. Board of Director Five will be elected at the annual meeting in March of 2020 and will be held by an individual from Foxfire for two (2) years. Every election after the March 2020 annual meeting all Board of Director elections will be for a two (2) year term.

Any Director may be removed from office at any time with or without cause by the affirmative vote of the Members, except that the Directors elected or appointed by the Declarant, as defined in the Declaration, may be removed only by the Declarant.

2. This amendment was made in accordance with the amendment procedure established in the Articles of Incorporation of Amherst Village, Inc., Article IX.


