ARTICLES OF INCORPORATION OF INNER CITY CORPORATION

SECRETARY OF STATE TALLAHASSEE, FLORIDA

ARTICLE I NAME

The name of the Corporation shall be the INNER CITY CORPORATION.

ARTICLE II PRINCIPAL OFFICE

The principal office of the Inner City Corporation is to be located in at 17977 SE 107th Court, Summerfield, FL 34491, Marion County, Florida.

ARTICLE III PURPOSE

The purpose for which this Corporation is organized shall be to promote and assist communities in their efforts to create jobs, eliminate blight and blighting influences, create affordable housing, secure adequate community and related facilities, and addressing the needs of the low to moderate income residents of communities and neighborhoods in Florida and other states. The Inner City Corporation shall engage in any and all lawful activities that are permitted of the State of Florida and Section 501 © (3) of the Internal Revenue Code.

The general purposes and powers are to have and to exercise all rights and powers conferred on not for profit corporations under the laws of Florida. All of the foregoing purposes and powers shall be exercised exclusively for charitable and educational purposes in such manner that the Corporation shall qualify as an exempt organization under Section 501 © (3) of the Internal Revenue Code as it is currently or herein after may be in force and effect.

ARTICLE IV MANNER OF ELECTION

Election: the Board of Directors shall elect the officers of the Corporation each year. Commencing with the first annual meeting and at each annual meeting thereafter, Directors shall be elected in the following manner: The Nominating Committee shall submit a slate of proposed Directors at the February meeting and election of Directors shall take place at the meeting.

Term of Office: The Board elected at the first annual meeting shall consist of three (3) groups as nearly equal in number as possible, with the groups being elected for respective terms of one, two and three years. Thereafter the terms of Directors shall be for three (3) years. The term of any Director may be shortened or lengthened by the Board to comport with any change in the fiscal year or date of annual meeting of the Corporation.

ARTICLE V INITIAL DIRECTORS AND/OR OFFICERS

The officers of the Corporation shall be the officers of the Board of Directors. The officers shall be Chairman, Vice Chairman, Secretary, Treasurer, and such other officers as may be provided in the By Laws. ARTICLE VII AMENDMENT TO ARTICLES OF INCORPORATION

ARTICLE VIII BY LAWS

The Board of Directors, by a majority vote of all Directors then in office, shall make, amended, altered or repealed the By Laws to govern the management and administration of the Corporation in a manner not inconsistent with these Articles of Incorporation.

ARTICLE IX DISSOLUTION

In the event of dissolution of the Corporation or the winding up of its affairs, all of the assets of the Corporation shall be distributed exclusively to charitable, religious, scientific, literary, or educational organizations which then qualify under the provisions of Section 501 © (3) of the Internal Revenue Code (or a corresponding provision of any future Internal Revenue law) as the Board of Directors shall determine.
