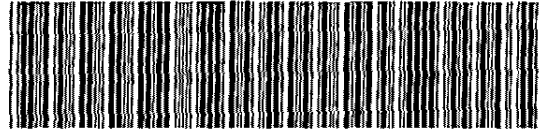

Article I. Name

The name of the corporation shall be: Mayan Family Services, Incorporated

Article II. Principal Office
