The undersigned subscriber(s) to these Articles of Incorporation, natural person(s) competent to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I- NAME

The name of the corporation is Making Lives Better Enterprises Inc.

ARTICLE II- PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be 11035 S. W. 142 Lane, Miami, Florida 33176.

ARTICLE III - PURPOSE

The corporation is organized to promote community awareness and provide an outreach for people of all ages and from all walks of life. A forum that seeks to help and offer people an arena for encouragement, support, inspiration, hope, and to improve the quality of life for themselves and their families. To buy affordable homes in distress areas, rent these homes at a price where a portion of the rental payments go towards the purchase of these for affordable families to provide better housing for themselves and their families.

ARTICLE IV - THE MANNER OF ELECTION

The manner in which the directors are elected or appointed by a forum of three (3) committee members with each member casting one (1) vote upon the election of the officers. The directors and the other members of the committee shall constitute a quorum of the meeting each second Saturday of each month. Vacancies in the Executive Committee shall be filled by a vote of the majority of the remaining members of the Committee. At no time shall the Executive Committee be less than three (3) Members. The Secretary shall be appointed by the Executive Committee and serve a term of no less than three (3) years. Each Committee member shall have one vote and proxy may not do such voting. At no time should the committee be less than two (2) members.
