Pursuant to Section 617.1002 and 617.1006 of the Florida Not-For-Profit Corporation Act (the "Act"), **PALM BEACH PRAYER TEAM MINISTRIES, INC.**, a Florida not for profit corporation, adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the company is **PALM BEACH PRAYER TEAM MINISTRIES, INC.** (the "Company").

SECOND: The Articles of Incorporation of the Company were filed with the Florida Department of State on June 7, 2004, under Document Number N04000005677.

THIRD: The following amendment to the Articles of Incorporation was adopted by the Company:

Article I of the Articles of Incorporation is hereby amended to read as follows:

ARTICLE I -- NAME

The name of this not-for-profit corporation is **PALM BEACH PRAYER MINISTRY, INC.** (the "Company").

FOURTH: The date of the adoption of the amendment was May 11, 2021.

FIFTH: The amendment was adopted by the board of directors, as required by this chapter and by the articles of incorporation and bylaws, and that member approval was not required.
