We, the undersigned subscribers to these Articles of Incorporation, each a natural person, competent to contract, hereby make, subscribe, acknowledge and file these Articles for the purpose of becoming a Corporation not for profit pursuant to Chapter 617.0202, Florida Statues.

# **ARTICLE I: NAME**

The name of the corporation shall be Renew Minds, Incorporated

# ARTICLE II: PLACE OF BUSINESS

The principal place of business shall be in the County of Hillsborough, State of Florida as determined by the Board of Directors. The mailing address is: 2907 Cord Street, Tampa, Florida 33605

### ARTICLE III: PURPOSE

- . The lawful purpose for which this corporation not for profit is organized is as follows:
- 1. To provide assistance to newly release incarcerated individuals.
- 2. To provide assistance to individuals that is homeless.
- 3. To provide technical training, transportation, and job skills to individuals released from the Department of Corrections and the homeless.
- 4. To establish short and long term goals for these individuals.
- 5. To develop interpersonal skills and career development for released incarcerated individuals and individuals that are homeless.

# **ARTICLE IV: BOARD OF DIRECTORS**

The Board of Directors shall consist of not less than three (3) individuals from the community.

The Board of Directors shall be elected at the annual meeting of the directors and each directors shall hold office for a term determined by the board of directors and until his or her successor is duly elected and qualified or until his or her death, resignation or removal from office.

Each person named in the Articles of Incorporation as a member of the initial Board of Directors shall hold office for an initial term of five (5) years and until his or her successor have been elected and qualified or until his or her death, resignation, or removal from office.

# ARTICLE V: REGISTERED AGENT

The registered agent of this corporation shall be Santiago Vasquez, 2907 Cord Street, Tampa, Florida 33605.

### ARTICLE VI: TERM OF EXISTENCE

This corporation not for profit shall have perpetual existence.

# **ARTICLE VIII: BASIS OF OPERATION**

No part of the net earnings of the organization shall inure to the benefit of, or be distributed to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distribution in furtherance of the purpose set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

The By-Laws of this corporation shall be made by the Board of Directors and may be amended or rescinded as provided therein.
