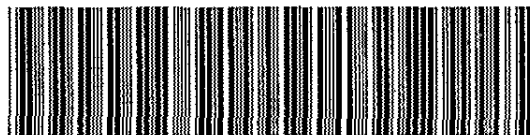

Articles of Incorporation of  
ASSOCIATION OF MEDICAL ESTHETIC NURSES, INC.  
A NONPROFIT CORPORATION

The undersigned, natural person of the age of eighteen years or older, acting as incorporator for the purpose of creating a nonprofit corporation under the laws of the State of Florida in compliance with Chapter 617, F.S., do hereby set forth:

- Article I The name of the corporation is Association of Medical Esthetic Nurses, Inc.
- Article II The principal place of business and mailing address of this corporation is:  
2000 So. Andrews Ave., Ft. Lauderdale, FL 33316
- Article III The purposes for which the corporation is organized are:  
a. Association of Medical Esthetic Nurses, Inc. is organized as a professional business association of Aesthetic Nurses, 1) promoting business standards, methodology, cooperation and unity in the profession and 2) promoting the profession itself to the general public.  
b. Notwithstanding any other provision of these Articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax under Section 501(c)(6) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.
- Article IV The officers/trustees/directors of the corporation shall be elected in the manner and for the terms provided in the Bylaws.
