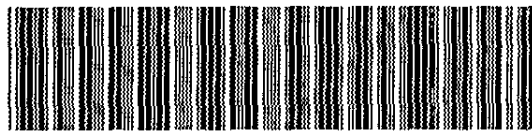

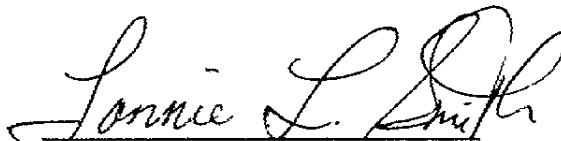
ARTICLE VII. ELECTION AS A TAX-EXEMPT, NOT FOR PROFIT CORPORATION.

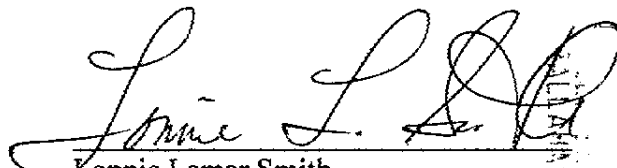
Certificate Designation and Acceptance of Registered Agent/Registered office
