ARTICLE I: CORPORATE NAME

The name of the corporation shall be: **ONLY THE CREATOR IS GOD, INC.**

ARTICLE II: CORPORATE EXISTENCE

The corporate existence of this corporation shall commence with the filing of the Articles of Incorporation and shall exist perpetually thereafter, unless dissolved sooner in accordance with the law.

ARTICLE III: PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:
12747 Spring Run, Clermont, FL 34711

ARTICLE IV: PURPOSE

The general nature of the objectives and purposes of this corporation is to worship only the Creator as God and to propagate this concept among mankind, that we are all equal as creations of the Creator, to propagate the peaceful coexistence among each other, to respect the right of all people to worship whatever god they choose, and to promote a greater understanding of our belief through education, community service, and outreach programs to people of all faiths, color, and gender, and to perform all such lawful acts that shall aid in the achievement of these objectives and purposes.

ARTICLE V: MANNER OF ELECTION

The Trustees shall be elected through a nomination and election process. Trustees will serve 2 or 3 year terms, as assigned to each seat. A Board of Directors will be appointed annually by the Board of Trustees to carry out the day to day operations of the corporation.

ARTICLE VI: BOARD OF TRUSTEES:

This corporation shall have five Trustees. The number of Trustees may be either increased or decreased from time to time, but shall never be less than three. The Board of Trustees will have absolute power in making all decisions that are vital to the existence and endeavors of the corporation. The Board of Trustees will also have the right to appoint and dissolve any Board of Directors as they see fit.

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved at a meeting of the Board of Trustees of the corporation by a statement manifesting their intention that a certain amendment of these Articles of Incorporation be made.


ARTICLE XI: IRS CODE COMPLIANCE AND DISSOLUTION

The corporation is organized exclusively for charitable, religious and/or educational purposes within the meaning of 501 (c) 3 of the Internal Revenue Code.

Notwithstanding any other provision of these articles, the corporation shall not carry out any activities not permitted to be carried on by on (a) by a corporation exempt from Federal income tax under section 501 (c) 3 of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue law or (b) by corporation contributions which are deductible under section 170 (c) 2 of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue

Upon dissolution of this corporation, assets will be distributed for one or more exempt purposes within the meaning of 501 (c) 3 of the Internal Revenue Code or corresponding provision of any future Federal tax code), or shall be distributed to the Federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the corporation is then located, exclusively for such purposes or such organization or organizations, as the court shall determine, which are organized and operated exclusively for such purposes.
