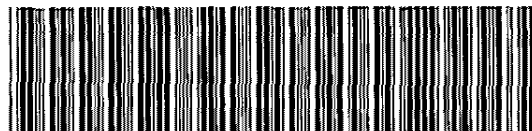

IN ACCORDANCE WITH Sections 617.0202 and 617.0203, Florida Statutes, the undersigned incorporator files the following Articles of Incorporation:

**ARTICLE I
Name**

The name of the corporation is **Lively Technical Center Foundation, Inc.**

**ARTICLE II
Principle Office**

The principle office and mailing address of the **Lively Technical Center Foundation, Inc.** is 500 North Appleyard Drive, Tallahassee, FL 32304.

**ARTICLE III
Purpose**

This corporation shall be a not-for-profit corporation operated under Chapter 617, Florida Statutes. This organization is organized and operated exclusively for charitable purposes within the meaning of section 501(c)(3) of the Internal Revenue Code. Notwithstanding any other provision of these articles, the **Lively Technical Center Foundation, Inc.** shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue law) or (b) by any organization contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1986 (or corresponding provision of any future United States Internal Revenue law). Without limiting the generality of the foregoing, the purposes of the Corporation include, but are not limited to: (1) promoting the objectives of Lively Technical Center, (2) supporting educational programs and activities of the school including financial aid to students, (3) encouraging research and learning and the dissemination of information, relating thereto, and (4) soliciting gifts to promote and support the objectives of the school.

ARTICLE IV
Manner of Election of Directors

Directors of the Corporation shall be elected as set forth in the Corporation's By-Laws and shall serve until their successors are elected. Until By-laws have been adopted, directors shall be elected as provided in Chapter 617, Florida Statutes, or any statute adopted in succession thereof.

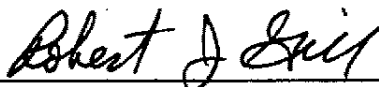

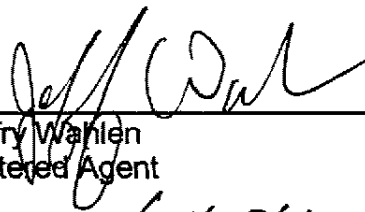
