ARTICLES OF INCORPORATION

The undersigned incorporator and each undersigned initial director sign and deliver these Articles of Incorporation in order to form a corporation not for profit under the laws of the State of Florida.

ARTICLE I: NAME & PRINCIPAL ADDRESS

ARTICLE II: PURPOSE

This is a not-for-profit corporation under Chapter 627 of the Florida Statutes. This organized for the exclusive purposes permitted under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, and the corresponding Regulations of the United States Department of Treasury, or the corresponding provisions of any future United States Internal Revenue law or Regulation of the United States Department of Treasury or any successor governmental agency (i.e., religious, charitable, religious, scientific, literary

The express, but not limited, purpose of this corporation is the advancement of the sport of water polo and its use as a motivational tool for promoting the education, health, welfare, and sound morals of the present generation of young persons and those of future generations to come.

Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, and the corresponding Regulations of the United States Department of Treasury, or the corresponding provisions of any future United States Internal Revenue law or Regulation of the United States Department of Treasury or any successor governmental agency

Upon dissolution of the organization, its remaining assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, and the corresponding Regulations of the United States Department of Treasury, or the corresponding provisions of any future United States Internal Revenue law or Regulation of the United States Department of Treasury any successor governmental agency, or shall be distributed to the Federal, state or locally government for a public purpose. Any such assets not so disposed of shall be disposed by a court of competent jurisdiction, in the county in which the principal office of the organization is then located, exclusively for such purposes.

ARTICLE HI: MEMBERS
