**ARTICLES OF INCORPORATION**

We, the undersigned, hereby associate together for the expressed purpose of becoming incorporated under the provisions of Chapter 617, Florida Statutes:

**ARTICLE I**

The name of the corporation shall be Dellwood Baptist Church of Dellwood, Florida, Inc. located in Jackson County, Florida.

**ARTICLE II**

The principal place of business is Dellwood Baptist Church, 6512 Blue Springs Road, Greenwood, Florida 32443.

**ARTICLE III**

The purpose or purposes for which this corporation is organized shall be of a religious society. A Church Society designed exclusively for charitable, religious and educational purposes within the meaning of Florida Laws and Section 501(c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law(s). Including, but not limited to, for such purposes, the establishing and maintaining of religious worship. The building maintaining and operating of churches, parsonages, schools, colleges, chapels, radio station, television station, rescue missions, missionary auxiliaries, print shops, day care centers, camps, nursing and retirement homes, cemeteries, and any other ministries that the church may be led of God, all of which are established for the benefit of the members of Dellwood Baptist Church by providing opportunities for spiritual, physical, intellectual, social, and cultural development.

**ARTICLE IV**

**The Election of the Board of Deacons**

The manner in which Deacons are elected shall be at any regular or special meeting of the Church upon recommendation from an ordination council or by existing Deacons of the Church. Deacons are to be servants of the Church in accordances with New Testament, meaning of work and practice. The Deacons shall serve as the Church Trustees and hold in trust the property of the Church. They shall have no power to buy, sell, mortgage, lease, or transfer any property without a specific vote or approval of the Church Membership authorizing each action.
