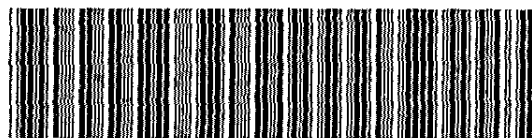

**Articles of Incorporation**

(In compliance with Chapter 617, F.S. Not for profit)

Articles of Incorporation of the undersigned, all of whom are citizens of the United states, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of the State of Florida, do hereby certify:

**ARTICLE I NAME**

The name of the corporation shall be

**BARSKY GREENSTEIN FOUNDATION INC.**

**ARTICLE II PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be

**ARTICLE III PURPOSE**

The purpose for which the corporation is organized is:

1. Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 5029(c)(3) of the Internal Revenue Code or the corresponding section of any future federal tax code.
2. To receive gifts of principal and to generate income from that fund, 95% of which shall be distributed annually to:
  - a. Other tax exempt charitable organizations.
  - b. Grants to individuals for cultural purposes (grants limited to 10% of Foundation income).

**ARTICLE IV MANNER OF ELECTION**

The manner in which the directors are elected or appointed:

**Directors shall be elected by unanimous consent of the membership.**

**ARTICLE VI     EARNINGS, etc.**

1.     No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Three hereof.

2.     No part of the activities of the corporation shall be for the purposes of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in any political campaign.

3.     The corporation shall not carry on any activities not permitted by a corporation exempt from Federal income Tax under section 501 ©(3) of the Internal Revenue Code.

**ARTICLE VII     DISSOLUTION**

1.     Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501©(3) of the Internal Revenue Code, or shall be distributed to the federal, state or local government for a public purpose.




