**ARTICLES OF INCORPORATION  
OF

The undersigned, pursuant to the provisions of Chapter 617 of the Florida Statutes, for the purpose of forming a non-profit corporation under the laws of the State of Florida, sets forth the following:

**ARTICLE I - NAME**

The name of this corporation shall be: Northwest Florida Surfing Association, Inc., (the "The Non-Profit Corporation"). 1255 North Eglin Parkway, Shalimar, Florida 32579

**ARTICLE II - PERIOD OF DURATION**

The period of duration of the Corporation shall be from the date of filing these Articles with the Department of State until the first to occur of the following:

- (i) Thirty (30) years from the date of filing of these Articles of Incorporation with the Department of State, or
- (ii) Dissolution of the Non-Profit Corporation pursuant to law.

**ARTICLE III - PURPOSE**

The purpose for which the corporation is organized is to further the sport of surfing and to protect the interests of Surfers in Northwest Florida.

**ARTICLE IV - MANNER OF ELECTION**

Thirty days notice of elections shall be given to the membership prior to officer elections.

Officer elections shall be held annually. The manner in which the directors are elected or appointed shall be by floor nomination and simple majority of the electorate present.
