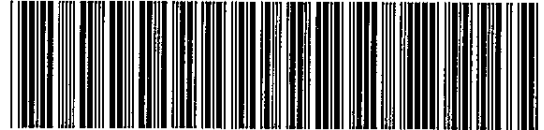

ARTICLES I -NAME

The name of this corporation shall be: UNIQUE KIDS, INCORPORATED

ARTICLES II - NATURE OF BUSINESS

This corporation may engage in or transact any and all-lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, county, territory or nation. 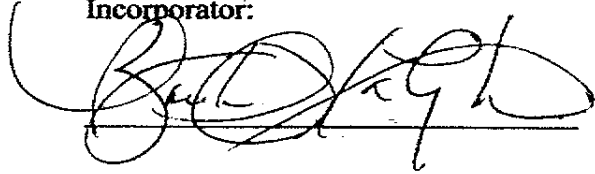
