### **Articles of Incorporation**

**Articles of Incorporation** of the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation Law of Florida, do hereby certify:

#### **Article I**

The Name of Corporation shall be Community Affordable Supported Housing, Inc.

#### **Article II**

The place in this where the principle office of the Corporation is to be located is the 623 Beechwood Street, City of Jacksonville, Duval County.

#### **Article III**

This corporation is organized exclusively for charitable cause and the enhancement of the quality of life for persons living with disabilities and the making of distributions to this organization and qualifying as an exempt organization under section 501 © (3) of the Internal Revenue Code, and the corresponding sections of any future federal tax code.

#### **Article IV**

The names and addresses of the persons who are the initial Trustees/Officers of the corporation are as follows:

#### **Article V**

No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth in Article three hereof. No substantial part of the activities of this corporation

shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under section 501 © (3) of the internal Revenue Code, or the corresponding section of any future federal tax code, or by a corporation, contributions to which are deductible under section 170 © (2) of the Internal revenue Code, or the corresponding section of any future federal tax code. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.


#### Article VI

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 © (3) of the Internal Revenue Code, or the corresponding section of any future federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of Duval County, exclusively for such purposes or to this organization, as said Court shall determine, which are organized and operated exclusively for such purposes.






