### ARTICLES OF INCORPORATION In Compliance with Chapter 617, F.S.

#### **OF**

## THE JAMES AND EMMA BLUE FAMILY REUNION, INC. (A NOT-FOR-PROFIT CORPORATION)

The undersigned, acting as incorporators of a Corporation under the Not For Profit Corporation Act of the State of Florida, adopt the following Articles of Incorporation for such Corporation.

#### ARTICLE I

The name of the corporation shall be:

"The James and Emma Blue Family Reunion, Inc."

#### **ARTICLE II**

The principal place of business and mailing address of this corporation shall be:

#### ARTICLE III

The purpose for which the corporation is organized is: To provide education and support for members and associates through charitable giving. As well as coordinate and promote activities designed to enhance the enrichment of the membership. Additionally, this corporation shall have the ability to own, acquire, sell and maintain physical assets, as well as provide any and all services that are legal and permissible under Chapter 617, F.S.

#### ARTICLE IV

Upon the dissolution of the Corporation or the winding up of its affairs, the assets of the Corporation shall be distributed exclusively to one or more charitable, religious, scientific, testing for public safety, literary, or educational organization which would then qualify under the provisions of Section 501 (c)(3) of the Internal Revenue Code and its Regulations as they now exist or as they may be hereafter amended, or to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the Corporation is then

located, exclusively for such purposes or to such organization or organization as said Court shall determine, which are organized and operated exclusively for such purposes.

#### ARTICLE V

The qualification for members and the manner of their admissions shall be regulated by the by-laws.

#### **ARTICLE VI**
