The Environmental Council of Volusia and Flagler Counties may be dissolved only with authorization by its Executive Board given at a special meeting called for that purpose and with subsequent approval by a two-thirds (2/3) vote of the current members. Upon dissolution or other termination of the Environmental Council, all remaining assets of the Environmental Council, after payment in full of its debts, obligations, and necessary final expenses, or after the making of adequate provision therefor, shall be distributed to such tax-exempt organizations (with purposes similar to those of the Environmental Council) as shall be chosen by the then existing Executive Board of the Environmental Council.
