## ARTICLES OF INCORPORATION OF ORLANDO GYMNASTICS PARENTS ORGANIZATION INC. (a Florida corporation not-for-profit)

#### **ARTICLE IV - PURPOSES AND POWERS OF CORPORTATION**

D. Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

### <u>ARTICLE X – DISSOLUTION OF CORPORATION</u>

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposed or to such organizations as said Court shall determine, which are organized and operated exclusively for such purposes.
