ARTICLES OF INCORPORATION

OF

A Florida Corporation Non Profit

Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of incorporation.

ARTICLE I

The name of the corporation shall be HAITIAN AMERICAN COMMUNITY ALLIANCE, INC. (the "Corporation").
