The corporation is organized for the following purpose or purposes:

This corporation is organized exclusively for one or more of the purpose as specified in Section 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.
