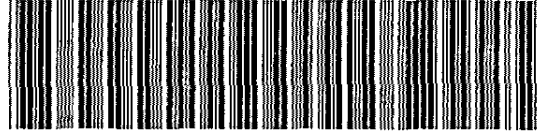

A purpose of BOARDRIDERS OF ALACHUA, INC. is to promote the erection of recreational structures through private donations, thereby lessening the financial burden of local government and combating the tension associated with skateboarding activities on unauthorized or prohibited properties.

#### **ARTICLE FIVE COMPENSATION FOR SERVICES**

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members or officers or other private persons, except that the organization shall be authorized to pay reasonable compensation for services rendered and to make payments in furtherance of the purposes of the organization.

#### **ARTICLE SIX DISSOLUTION OF ORGANIZATION**

Upon dissolution of BOARDRIDERS OF ALACHUA, INC., assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the City of Alachua or Alachua County government for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of Alachua County exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purpose.


