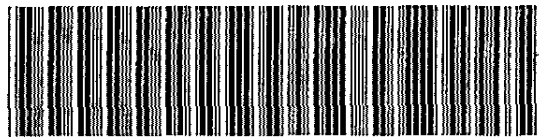

Amended Purposed of Trinity Restoration Reform Outreach Ministry, Inc.

Section III: Purpose: *The purpose for which the corporation is organized is:*

A. The purpose for which **Trinity Restoration Reform Outreach Ministry** is organized are exclusively for religious, charitable, scientific, literary and educational within the meaning of section 501(C) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law. purpose.

B. Notwithstanding any other provisions of these articles, the organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

C. Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding section of any future Federal tax code, or shall be distributed to the Federal, state, or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes.

D. To support and provide services to the underprivileged and distressed through the Word of God. To create a spiritual environment through the Word of God that will restore, renew and rebuild the minds of our community through education training, career development. To help prevent community deterioration and build positive behaviors and character through the Word of God.

E. *Conflict of Interest Policy:* Any director, officer or key employee who has an interest in a contract or other transaction present to the Board or a committee thereof for authorization, approval, or ratification shall make a prompt and full disclosure of his interest to the Board or committee prior to its acting on such contract or transaction.
