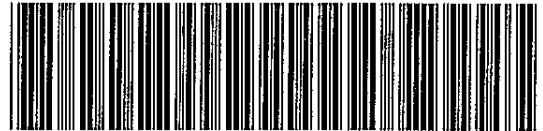

ARTICLE ONE - NAME

The name of the corporation shall be "Citizens for a Sustainable Future, INC."

ARTICLE TWO - PRINCIPAL OFFICE

The principal place of business and mailing address of the corporation shall be as follows:

ARTICLE THREE - PURPOSE

The corporation is a formation of long-term community stakeholders who support sustainable community planning and investment to, among other things,

- a) Create a climate and culture of long term planning, improve sources and methods of funding and early implementation of infrastructure, sustainable smart growth policies together with promotion of strict adherence to Land Development Code and Comprehensive Plan by governmental officials as well as citizens;
- b) Collect and utilize data to determine citizen attitudes on issues of community importance;
- c) Create educational programs and materials to promote sustainable policies as determined by the members; and
- d) Create a broad based public dialogue on issues such as the foregoing.
