AMENDMENT TO ARTICLES OF INCORPORATION OF SEMINOLE HISTORICAL SOCIETY, INC. (A Corporation Not for Profit)

O6 JAN 26 AMI

We, the undersigned, being all of the Directors of this Corporation, hereby execute he following Amended Articles of Incorporation for the purpose of amending the Articles of Incorporation previously filed on July 2, 2004 under file number N04000006624.

Name: The name of this Corporation is the SEMINOLE HISTORICAL SOCIETY, INC., whose mailing address is 9075 Seminole Boulevard, Seminole, Florida 33772.

ARTICLE IV - Purpose, is deleted and amended in it's entirety to read:

- (A) The specific purpose for which this Corporation is organized is to provide for worthy community needs, for the advancement of education and literacy, and to preserve the past and future history of the area known as Seminole, in the County of Pinellas, State of Florida, providing for a museum for the preservation of artifacts, and to possess all rights, privileges and immunities, and enjoy all the benefits and powers granted to Corporations not for profit under the laws of the State of Florida, and the United States of America.
- (B) Notwithstanding the foregoing, and to supercede the same where in conflict, the general purposes for which the Corporation is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

ARTICLE VI - Non-Profit Status, is deleted and amended in it's entirety to read:

- (A) The Corporation shall have no capital stock and shall declare no dividends, and the profits, or other income, if any, of the Corporation, from whatever source, shall be used solely in promoting the purpose thereof, and no portion thereof shall be paid or transferred directly or indirectly by way of dividend, bonus or otherwise, in any manner of profit to the Directors, Officers, or Members of this Corporation. However, nothing herein shall prohibit the payment in good faith of reimbursement to any Director, Officer, or Member for out of pocket expenses or reasonable compensation for services actually rendered on behalf of the Corporation.
- (B) Limitation on Powers:
 - (1) Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501(c)(3) of the Internal

Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

- (2) Specifically, this organization shall:
 - a. Absolutely refrain from participating in the political campaigns of candidates for local, state or federal office.
 - Absolutely ensure that its assets and earnings do not unjustly enrich board members, officers, key management employees, or other insiders.
 - c. Not further non-exempt purposes (such as purposes that benefit private interests) more than insubstantially.
 - d. Not operate for the primary purpose of conducting a trade or business that is not related to its exempt purpose(s).
 - Not engage in activities that are illegal or violate fundamental public policy.
 - f. Restrict its legislative activities.

ARTICLE V - MANAGEMENT OF CORPORATE AFFAIRS shall have deleted therefrom the third (3rd) paragraph thereof, beginning with: "Directors elected at the first meeting..." and ending with "... as the Board of Directors may designate from time to time by resolution."

ARTICLE VII - Distribution of Assets: is amended to read: "Distribution of Assets upon Liquidation."
