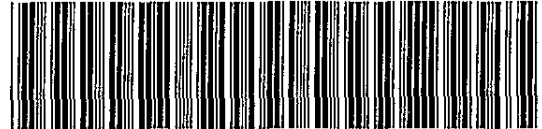



**ARTICLES OF INCORPORATION
OF
THE HOUR OF YOUR TIME FOUNDATION, INC.**

The undersigned for the purpose of forming a corporation under Chapter 617 of the Not for Profit Corporation Law of the State of Florida hereby certify:

1. **Name and Address.** The name of the corporation is THE HOUR OF YOUR TIME FOUNDATION, INC., the initial principal office and mailing address of the corporation shall be 5310 Montclair Place, Sarasota, Florida.

2. **Exempt status.** The Corporation is constituted so as to attract substantial support from contributions, directly or indirectly, from a representative number of persons in the community in which it operates and has not been formed for pecuniary profit or financial gain, and no part of the assets, income or profit of the Corporation is distributable to, or inures to the benefit of, its directors or officers except to the extent permitted under the Not-for-Profit Corporation Law. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting, to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law) or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States internal revenue law).

3. **Purposes.** The purposes for which the Corporation is to be formed are for scientific, educational, and charitable purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code of 1954 and in this connection, to promote the welfare of children in home, school, and community, to raise the standards of their lives and to that end raise funds for children's organizations and to assist there organizations responsible for children's activities both in their healthcare and their general welfare, education, instruction, entertainment and recreation, their employment and in health related organizations to assist same organizations in the prevention of any disorder befalling children to these ends to take and hold by bequest, devise, gift, grant, purchase, lease or otherwise any property, real, personal, tangible or intangible, or any undivided interest therein, without limitation as to amount or value; to sell, convey, or otherwise dispose of any such property and to invest, reinvest or deal with the principal or the income thereof in such manner as, in the judgment of the directors, will best promote the purpose of the Corporation without limitation, except such limitations, if any, as may be contained in the instrument under which such property is received, this Article of Incorporation, the Bylaws of the Corporation, or any laws applicable thereto. To do any other act or thing incidental to or connected with the foregoing purpose or in advancement thereof, but not for the pecuniary profit or financial gain of its directors or officers except as permitted under the Not-for-Profit Corporation Law. In furtherance of its corporate purposes, the Corporation shall have all general powers enumerated in Chapter 617 Florida Statutes.

4. **Place of Operation.** The territory in which the Corporation's activities are principally to be conducted is throughout the United States.

5. **Names of Directors and Manner of Election.** The names and addresses of the directors until the first annual meeting:

A vacancy in the Board of Directors shall be filled by the remaining Director or Directors. If there is no Director, a petition filed with the Circuit Court of Sarasota can request that the Court appoint Directors to operate said foundation.

6. **Distribution on dissolution.** In the event of dissolution, all of the remaining assets and property of the Corporation shall, after necessary expenses thereof, be distributed to such organizations as shall qualify under Section 501(c)3 of the Internal Revenue Code of 1954, as amended.

7. **Income and distribution.** No part of the income of the Corporation shall inure to the benefit of any member, trustee, director, officer of the Corporation, or any private individual (except that reasonable compensation may be paid for services rendered to or for the Corporation affecting one or more of its purposes), and no member, trustee, director or officer of the Corporation or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the Corporation.


8. **Prohibited activities.** No part of the activities of the Corporation shall be carrying on propaganda, or otherwise attempting to influence legislation, or participating in, or intervening in (including the publication or distribution of statements), any political campaign on behalf of any candidate for public office.

9. **Address for Notice.** The post office address to which the Secretary of State shall mail a copy of any notice required by law is 5310 Montclair Place, Sarasota, Florida, 34231.


10. **Age of subscriber.** The subscribers are of the age of 18 years or over.

11. **Registered Agent and office.** The registered agent and office for this Corporation is Gary E. Massey, 100 W. Citrus Street, Altamonte Springs, Florida, 32714.



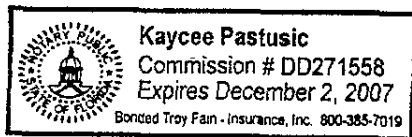
