- 1. Article IV of said Articles of Incorporation presently reads:

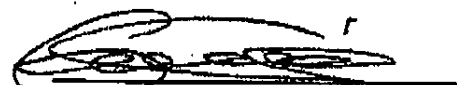

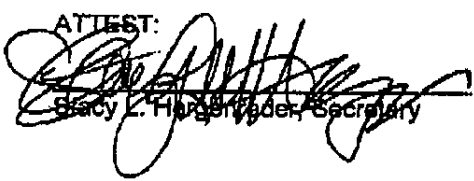
and shall be amended to read as follows:
