The undersigned, acting as incorporator(s) of a corporation pursuant Chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation of such corporation:

ARTICLE I

The period of duration this corporation is perpetual unless dissolved in accordance to the law.

ARTICLE III


