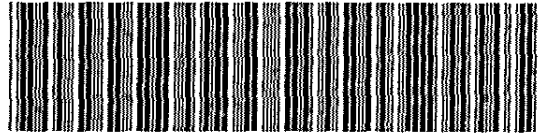

## **Article 1.**

The name of the corporation is Gilead Tutorial and Learning Center.

## **Article 2.**

The duration of this corporation shall be perpetual, it is authorized to issue (0) shares, and shall have no members.

## **Article 3.**

- (B) Notwithstanding, any other provision of these Articles, the corporation shall not carry on any other activities not permitted to carry on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section (170)(c)(2) of the Internal Revenue Code.

## **Article 6.**

The principal mailing address of the corporation is 503 West Edgewood Avenue, Jacksonville, Florida, 32208.

#### **Article 7.**

The Directors are elected in accordance with the Bylaws. The name and address of the persons appointed to act as the initial Directors of this Corporation are:

#### **Article 8.**

The property of this corporation is irrevocably dedicated to Religious, Charitable, and Educational purposes and no part of the net income or assets of the organization shall ever inure to the benefit of any director officer or member thereof or the benefit of any private person.

#### **Article 9.**

On the dissolution or winding up of the corporation, its assets remaining after payment of, or provision for payment of, all debts, and liabilities of this corporation, shall be distributed to a nonprofit fund, foundation, or corporation, which is organized and operated exclusively for, Religious, Charitable, and Educational under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is located exclusive for such purposes or to such organization or organizations, as said Court shall determine which are organized and operated exclusively for such purposes.
