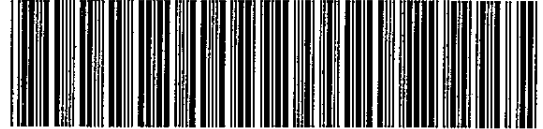

Notice is hereby given that the undersigned incorporators, all being of full age, have associated themselves together for the purpose of forming a corporation under the Florida Statutes and hereby adopt the following Articles of Incorporation.

ARTICLE ONE
CORPORATE NAME

The name of the corporation is **FLOROSA FIREFIGHTERS, INC.**

ARTICLE TWO
DURATION

The term of existence of the corporation is perpetual.

ARTICLE THREE
DEFINITIONS

The purpose for which the corporation is organized is: The corporation intends to provide residents with charitable assistance at funerals, parades; to present fire safety instruction in schools and day care center. Do fire prevention programs, distribute literature on fire prevention. Purchase, collect and distribute Christmas toys to needy children. COMMENCEMENT OF CORPORATE EXISTENCE

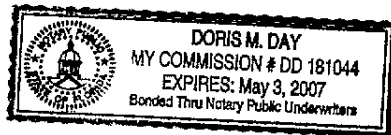
