**ARTICLES OF INCORPORATION
OF**

We the undersigned persons of the state of Florida, each being competent to contract, hereby form ourselves and our successors into a corporation not for profit under Chapter 617, Law of Florida, 1959, and do hereby adopt the following Articles of Corporation as our Charter:

Article I The name of this corporation shall be:

Iglesia Monte Sinaí , Asambleas de Dios, Incorporated

Articles II The principal place of business and mailing address of this corporation shall be:

Article III: The specific purposes for this corporation is organized are:

- (1) To propagate and disseminate the Gospel of the Lord Jesus Christ to the community so as to fulfill the Great Commission as commanded by our Lord and Savior Jesus Christ in the New Testament Bible.
- (2) To do all things necessary and proper in the pursuit of such objects and purposes.
- (3) To establish and maintaining a place for worship of Almighty God, our Heavenly Father; to provide for Christian fellowship for those of like precious faith.
- (4) To receive, administer, disburse and/or invest gifts, devises and requests by or from any persons or corporations.

Article IV: The manner in which the Directors are elected or appointed is as follows:

The Incorporator shall appoint the initial Board of Directors. Future Board member vacancies on the Board of Directors shall be filled accordingly: (a) The Pastor shall nominate director candidates and (b) a quorum of the Board of Directors shall grant final approval. If the number of Directors then in office is less than a quorum, a vacancy on the board may be filled by approval of a majority of the directors then in office or by a sole remaining director. A person elected to fill a vacancy on the board shall hold office until the next election of the Board of Directors or until his or her death, resignation or removal from office.
