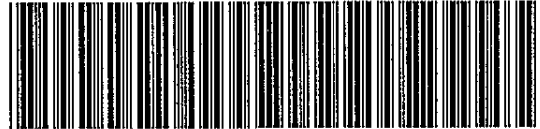

ARTICLE I. CORPORATE NAME

The name of this corporation is

ARTICLE II. PRINCIPAL OFFICE

ARTICLE III. TERM OF EXISTENCE

The period of duration of this corporation is perpetual.

ARTICLE IV. PURPOSES

The purposes for which the corporation is organized are:

- a. To develop the Communities that is determined by its Board of Directors
- b. To develop and implement a certification program for energy efficient and sustainable building development and community improvement practices.

Such program will be open to interested persons that are determined by the Board of Directors of the corporation regardless of whether these are members of this organization.

Provided however, that such program will not replace the requirements established by any governing board, for compliance with the community Safety and Efficiency.

This Corporation shall build, own operate and finance; community Services, develop Buildings and provide for ordinary services that are used by individuals, families and communities, including lands and buildings that the corporation will own, manage and operate.

To administer community building Services programs based upon the State of Florida standards, and other suitable standards that are developed by the board of directors.

This is a Not for Profit Corporation, organized for Educational, Economic, Political and Social Services Purposes; that are to Uplift, Mobilize, and Empower the Entire Community of Orlando, Central Florida and Similar Communities throughout the United States.

Further goals and purposes of this corporation are:

1. To educate the general public, businesses, institutional and governmental bodies of the Long term benefits of sustainable development and construction of community improvements, community and Services corporations,
2. To promote and educate the public about Safe Affordable Community development and building Services.
3. To improve the energy efficiency, energy conservation potential, indoor air quality, Water conservation potential and sustainability of community services buildings;
4. To encourage Safe Affordable Community Development Services.
5. To stimulate statewide acquaintance and fellowship among members and others Interested in Safe Affordable Food housing and community development Services.
6. To provide opportunities for members and other interested parties to increase their Knowledge of Safe Affordable Housing and Community Development Services.

Activities that are to be carried out by the corporation include and are not limited to: Community Recreation, Enlightenment, Development and Education Services, General Business Purposes Corporation for Profit.

ARTICLE V. MEMBERS

Any individual with an interest in the purposes of the corporation shall be eligible for Membership in accordance with the by-laws and rules and regulations in effect from time to time.

There shall be no limit on the number of members.

The by-laws of the corporation may provided for other classes of membership and the Board of Directors may also from time to time prescribe other classes of membership and also prescribe rights, privileges and duties of members, associates or other such classes as may from time be established.

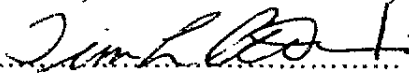
