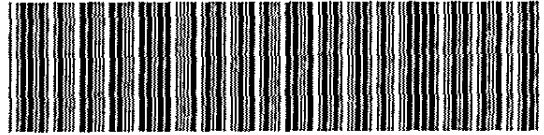

ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation pursuant to chapter 617 Florida Statutes, adopt the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation shall be:

The Exodus Bible Church, Inc.

ARTICLE II PRINCIPAL OFFICE

The principle place of business and mailing address of this corporation shall be:

Jacksonville, Florida 32210

ARTICLE III PURPOSE

The specific purpose for which the corporation is organized is:

To be a non-profit ecclesiastical corporation with the term of the existence of this corporation to be perpetual; also

- (1) To seek the salvation of the lost, through the preaching of the Gospel of Christ;
- (2) To adhere to the preaching of the Gospel for the reproof, rebuke, and exhortation of the saints; and
- (3) To promote Christian fellowship;

ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected or appointed is as follows:

The Pastor/President of the corporation shall select all officers to serve in their designated capacity. The Pastor/President will bring before the Membership those he has deemed suitable to serve as Officers for a Two (2) year Tenure. The Officers will be able to server concurrently as long as they perform their duties in accordance with the standards set by the Pastor.

The Membership shall have the supreme power and control over the administration of its ecclesiastical affairs, in accordance with God's Word, subject to the provisions of Articles of Incorporation and to the Constitution and Bylaws of the Church.

In order for an accepted Member to become a Voting Member, he/she Must:

1. Be a born-again believer in Christ who has reached the age of accountability;
2. Be a regular supporter of the financial/giving program of Tithes and Offerings;
3. Be a regular attendant of Worship Services.

Members having voting privileges shall be entitled to vote when present in person at the designated business meeting of the membership called for the purpose of voting on any issue with respect to which a vote is required as provided in this Constitution. Voting Members shall not be entitled to vote by proxy, and there will be no Secret Ballot Voting allowed at this church. Except as may other wise specifically provided herein, the
