The undersigned, acting as incorporator of a corporation pursuant to chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation.

ARTICLE I

Name

The name of the corporation shall be:

REFUGE TOUCH CHURCH, INC.

ARTICLE II

Principal place of business and mailing address

The principal place of business and the mailing address of this corporation shall be:

2700 Coolridge Avenue Orlando, Florida 32804

The Board of Directors may from time to time move the principal office to any other address in Florida, and so notify the Secretary of State.

ARTICLE III

Purpose(s)

The purposes(s) for which the corporation is organized is (are):

REFUGE TOUCH CHURCH, INC. is organized exclusively for charitable, religious, education, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501 (c)(3) of the Internal Revenue Code, or the corresponding section(s) of any future federal tax code.

It is the purpose of this corporation to advise, counsel and minister to all charitable organizations and persons regardless of race, creed or color wherever possible and specifically in all areas of gospel ministry through preaching, teaching, instruction and with financial aid.

The specific purposes of REFUGE TOUCH CHURCH, INC. are:

- 1. To proclaim the gospel of Jesus Christ to all people, in accordance with the Great Commission, and biblical doctrine, to awake, to care for and to promote Christian life according to the scriptures.
- 2. To provide spiritual growth opportunities through tutoring, preaching, teaching and mentoring to the body of Christ.
- 3. To establish the winning of souls within the church in order to perpetuate the discipling process.
- 4. To build up the family unit in their spiritual growth process.
- 5. To provide public worship, teaching of the word of God and training in relationships among the participants.
- 6. To act with charitable concern for all mankind regardless of race, social position or religious affiliation.
- 7. To provide biblical discipleship to believers wherever needed.

ARTICLE IV

Manner of election of Directors

The affairs of REFUGE TOUCH CHURCH, INC., both spiritual and secular, shall be conducted by the Board of directors, which shall consist, initially of three (3). The number of Directors may be varied from time to time as provided in the By-Laws; however, in no case may the number be less than three (3) as provided for in the Florida Statutes. Directors shall be appointed according to the provisions set forth in the By-Laws.

The Directors themselves must possess the qualifications of leaders as set forth in the relevant teachings of the New Testament and they shall have the duties as set forth therein. Directors, once in office, shall serve so long as they remain members of the church/ministry unless sooner removed as set forth in the By-Laws.

The Directors shall appoint such other persons as may be necessary to properly minister and carryout the purposes for which the church is organized. Persons so appointed shall be subject to the provision of Section 741.07, Florida Statutes, and to any rules or By-Laws which may be adopted by the Directors of the organization/church. Once appointed they shall serve so long as they remain members of the organization/church, unless sooner removed as set forth in the By-Laws.

The Board of Director will make every effort to act with unanimity. However, all actions of the Board shall be with the concurrence of at least 2/3rd s of the Directors, unless otherwise stated.

If any decisions which cannot be successfully resolved at a meeting of the Board of Directors, the matter will be considered and a final decision made by the President of the organization/church.

ARTICLE V

Limitation of corporate powers

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, unless limited as follows: NONE

Additional powers of the corporation:

- 1. To qualify for grants available for nonprofit projects;
- 2. To only engage in activities that further its religious, scientific, benevolent, charitable, literary and educational purposes. It shall engage only in such activities as are permitted to be carried on by corporations whose income is exempt from taxation pursuant to Section 501(c)(3), and whose contributions are deductible pursuant to Section 170(c)(2), of the Internal Revenue Code or future revisions.
- 3. No part of the activities of the corporation shall be for the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

4. No part of the Church's net earnings or assets may inure to the benefit of any director, officer or member, except as reasonable compensation for services rendered.

ARTICLE VI

Dissolution

If it is necessary or desirable to dissolve the corporation, the provisions of s.617.1402, s.617.1403, and s.617.1406 shall govern. The corporation may be dissolved by a unanimous vote of the full Board of Directors. In the event of such dissolution, the Board of Directors shall, after paying or making provision for payment of all the liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purposes of the corporation or such organization(s) organized and operated exclusively for charitable, religious, educational, or scientific purposes as shall at the time qualify as a exempt organization(s) under Section 501(c)(3) of the Internal Revenue Code or the corresponding provision(s) of any future United States Internal Revenue Code or Law. The Board of Directors shall determine to whom distribution will be made, but in any case no distribution may be made to any organization not qualified under Section 501(c)(3) of the Internal Revenue Code or the then current Federal Tax Code.
