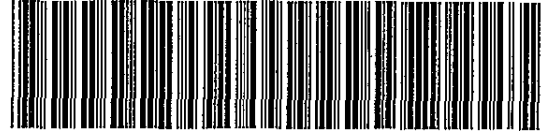

We the undersigned, with other persons desirous of forming a corporation not for profit under the authority and provisions of Chapter 617 of the Florida Statutes, do hereby associate ourselves together as a corporation not for profit and do hereby adopt the following articles of incorporation and submit the same for approval to the Secretary of the State of Florida.

ARTICLE I – NAME

The name of this organization is Sunsation Show Chorus, Inc.

ARTICLE II – PRINCIPAL OFFICE

**The principal office is located at 88 Nicholas Dr., Dunedin, FL 34698
Pinellas County, Florida
or at such other office as may from time to time be designated.**

ARTICLE III – PURPOSE

The general nature, purpose and objectives of this corporation are as follows:

- A. To provide a creative outlet for those persons interested in choral singing for the benefit and pleasure of the general public.**
- B. To present affordable concerts at regularly scheduled intervals for public enjoyment.**

ARTICLE IV – MANNER OF ELECTIONS

Executive Board Officers will be elected by the members at the final meeting of the fiscal year (April or May). Elected officers will assume their positions when the chorus reconvenes for the new season. The Executive Board will act as the nominating committee. A list of candidates must be presented to the membership 2 weeks before elections but candidates may also be nominated from the floor.

ARTICLE V – INITIAL DIRECTORS AND OFFICERS

The officers of the corporation shall be President, Vice-president, Secretary, Treasurer.

The business of this Corporation shall be managed by the Executive Board of Directors to consist of President, Vice-President, Treasurer, Secretary, Marketing Director, Membership Director, Artistic Director.
