

## ARTICLES OF INCORPORATION OF

# THE MOORINGS PARK INSTITUTE FOUNDATION, INCORPORATE $\widehat{\mathbf{D}}$ ...

## ARTICLE ONE - NAME

The name of the Corporation is The Moorings Park Institute Foundation, Incorporated,

# ARTICLE TWO – <u>ADDRESS OF PRINCIPAL OFFICE</u> AND MAILING ADDRESS OF CORPORATION

The mailing address and street address of the principal office of the Corporation is 120 Moorings Park Drive, Suite D, Naples, FL 34105.

#### ARTICLE THREE - PURPOSE

The purposes for which the Corporation is organized are to operate exclusively for charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as it now exists or may later be amended or replaced (the "Code") including, without limitation, the following:

- (1) To foster, promote, develop, encourage and accept funds for the construction, building, remodeling, support, administration, staffing, and any other legitimate purpose or function of organizations which are exempt from federal income taxation under Section 501(c)(3) of the Code.
- (2) To develop community and public education programs.
- (3) To solicit, receive and expend gifts and contributions for and on behalf of such charitable healthcare service organizations which are exempt from taxation under Section 501(c)(3) of the Code as the Board may from time to time determine.
- (4) To review and process grant applications and administer the expenditure of such grant funds as may be given to The Moorings Park Institute, Incorporated, Moorings Park Community Health, Incorporated or The Moorings, Incorporated, d/b/a Moorings Park.
- (5) To create, establish, manage, support and administer trusts and endowments, and appropriate the income and principal thereof for the benefit, support, improvement, upkeep, expansion, replacement and operation of The Moorings Park Institute, Incorporated, Moorings Park Community Health, Incorporated or The Moorings, Incorporated, d/b/a Moorings Park.

# ARTICLE FOUR - MANNER OF ELECTION

The affairs of the Corporation shall be managed by a Board of Directors whose members shall be elected or removed in accordance with procedures provided in the Bylaws.
