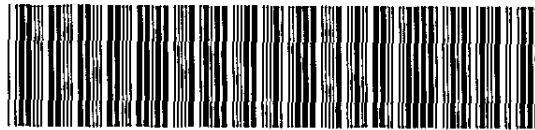

In Compliance with Chapter 617, F.S., (Not for Profit)

### **ARTICLE I        NAME**

### **ARTICLE III        PURPOSE**

The purpose for which the corporation is organized is:

The purpose of The Beta Nu Education Foundation, Inc. is to reward scholarship and increase social awareness among the African-American community. These initiatives will be accomplished through continuous programs encouraging individuals in the African-American community to pursue continuing education, learn about social issues effecting their daily lives, and to become politically astute in both local and national forums.

### **ARTICLE IV        MANNER OF ELECTION**

The manner in which the directors are elected or appointed:

The elections of the elected executive officers shall be held on the first regular meeting in April. All officers shall be elected by majority vote (50% + 1). If necessary, run-offs shall be conducted at the same meetings. All elections shall be by silent vote, unless otherwise decided by a two-thirds vote, with proper time given for debate, discussion, and then vote. Chapter officers shall serve one-year terms or until qualified successors are elected to fill their positions.
