### ARTICLES OF INCORPORATION

### A Florida Corporation Non Profit

Pursuant to the provisions of section 617.1005, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of incorporation.

#### ARTICLE I

The name of the comporation shall be WeCare Foundation, Inc. (the "Comporation"). Said comporation is organized exclusively for charitable, admostronal and striantific purposes including for such pumposes the making of distributions to organizations under section 501(c) (3) of the Internal Revenue Code (or the corresponding section of any future Federal tax code).

## ARTICLE II

The street address of the initial principal office of the Corporation shall be 111 Granada Ct., Orlando, Florida 32803.

## ARTICLE III

The purpose of this corporation :IS TO ASSIST THE NEEDY.

The Corporation shall also be authorized to engage in and transact any and all lawful business within and without the State of Florida or United States for which corporations not for profit may be incorporated under Chapter 617, Florida Statutes, as amended and supplemented. No part of the net earnings of the corporation shall inure to the henefit of, or be distributed to its manbers, trustees, directors, officers or other private persons except that the corporation shall be authorized and appowered to pay reasonable corporation for services rendered and to make payments and distributions in furtherance of section 501(c)(3) purposes. No substantial part of the activities of the corporation shall be the carrying on of propagenda or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in apposition to any candidate for public office. Notwithstanding any other provision of these Articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this Corporation.
