AMENDMENT TO THE ARTICLES OF INCORPORATION FOR CARRIAGE HOMES III AT MOODY RIVER ESTATES CONDOMINIUM ASSOCIATION, INC.

THE FOLLOWING AMENDMENT SHALL BE MADE TO OF THAT ARTICLES OF INCORPORATION FOR CARRIAGE HOMES III AT MOODY RIVER ESTATES CONDOMINIUM ASSOCIATION, INC., ATTACHED AS EXHIBIT C TO THAT CERTAIN DECLARATION OF CONDOMINIUM RECORDED ON DECEMBER 28, 2005 AS OFFICIAL INSTRUMENT NUMBER 2005000188482 IN THE PUBLIC RECORDS OF LEE COUNTY, FLORIDA (COLLECTIVELY THE "DECLARATION").

NOTE: Language being added is underlined and language being deleted is struck through.

I. ARTICLE VIII

ARTICLE VIII

AMENDMENTS: Amendments to these Articles may be proposed and adopted in the following manner:

- (A) Proposal. Amendments to these Articles may be proposed by a majority of the Directors, or by written petition to the Board signed by the owners of at least one-fourth (1/4) of the units.
- (B) Procedure. If any amendment to these Articles is so proposed, the proposed amendment shall be submitted to a vote of the members not later than the next annual meeting for which proper notice can be given.
- (C) Vote Required. Except as otherwise required by law, a proposed amendment to these Articles of Incorporation shall be adopted if it is approved by a majority Eighty percent (80%) of the total voting interests in the condominium which are eligible to vote at any annual or special meeting called for the purpose, or if it is approved in writing by a majority eighty (80%) of the total voting interests in the condominium which are eligible to vote without a meeting, provided that notice of any proposed amendment has been given to the members of the Association, and that the notice contains the text of the proposed amendment.
- (D) Effective Date. An amendment which is duly adopted shall become effective upon filing with the Secretary of State, and subsequently recording a certified copy in the Public Records of Lee County, Florida, with the same formalities as required for the recording of an amendment to the Bylaws.
