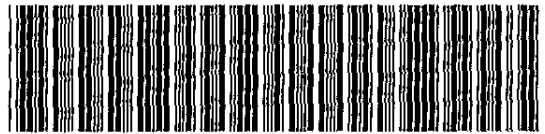

ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be:

A Blessing Adult Family Care Corporation

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

4806 Puritan Road Apt A, Tampa, Florida 33617

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

- a. The care center is a non-profit assistance living facility designed for the disabled and elderly. Who are having difficulties finding the help and services, of quality home care service. Also conduct itself in the manner of any and all lawful business.
- b. No part of the net earnings of the organization shall inure to the benefit of, or distributable to its members, officers or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distribution in furtherance of the purposes set forth in the purpose clause hereof. Notwithstanding any other provision of this document, the organization shall not carry on any other activities nor permitted to be carried on (a) by an organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code.
- c. Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501' (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government for a public purpose.

ARTICLE IV MANNER OF ELECTION

Directors shall be appointed by the President and shall hold office until the Director's prior resignation or removal.


