TO THE ARTICLES OF INCORPORATION FOR STONEYBROOK AT VENICE

STONEYBROOKAT VENICE COMMUNITY ASSOCIATION, INC., its address being c/o Advanced Management, Inc., 899 Woodbridge Drive, Venice, FL 34293, Sarasota County, by the hands of the undersigned hereby certify that:

The Master Declaration of Covenants, Conditions and Restrictions for STONEYBROOK AT VENICE COMMUNITY ASSOCIATION, INC. is recorded in Official Records Instrument # 200414927, of the Public Records of Sarasota County, Florida, and as amended. The following amendments to the Articles of Incorporation were approved by the Developer as permitted under the terms of the Master Declaration of Covenants, Conditions and Restrictions and the Articles of Incorporation while the Developer is in control of this community.

1. Article 2, first paragraph, is hereby amended to read as follows:

The nature of the business to be transacted shall be to engage in any activity or business permitted under the laws of the United States and of this State, pursuant to Chapter 617 of the Florida Statutes. The Association is organized for the purpose of providing an entity for the operation of a mixed use residential and commercial planned development, located in Manatee Sarasota County, Florida.

2. Article 10, Bylaws, is hereby amended to read as follows:

Bylaws of the Association may be adopted, made, altered or rescinded according to the manner described in the Bylaws by the Directors at any regular meeting or any special meeting called for that purpose, so long as they are not inconsistent with the provision of these Articles.

3. Article 11, Amendment, is hereby amended to read as follows:

Amendment to the Articles of Incorporation may be proposed by any Director at any regular or special business meeting of the Board of Directors at which a majority is present and, if obtaining a majority vote of the Board of Directors present and voting at such meeting properly called and noticed as provided in the Bylaws, shall be submitted to a vote of the membership. If approved by a majority vote of the membership at a meeting of the members properly

called and noticed as provided in the Bylaws, such Amendment shall be forwarded to the Secretary of State of the State of Florida and filed and shall become effective upon issuance, by said officer, of a certificate reflecting same. Notwithstanding the foregoing, the Declarant may, in its sole discretion, unilaterally modify or amend these Articles of Incorporation. This right to amend or modify shall expire at such time as no Developer holds any property for sale in the ordinary course of business within the Community:

- 11.1 Amendments. Amendments to the Articles of Incorporation shall be proposed and adopted in the following manner:
- 11.2 Notice. Notice of the subject matter of a proposed amendment shall be included in the notice of any meeting at which a proposed amendment is considered.
- 11.3 Proposing the Amendment. A Resolution for the adoption of a proposed amendment may be proposed either by the Board of Directors or by not less than twenty percent (20%) of the members of the Association.
- 11.4 Vote. These Articles of Incorporation can be amended, altered, or replaced only upon an affirmative vote of not less than two-thirds (2/3) of the Members who cast a vote, in person or by proxy, at a properly called Members' Meeting. Members not present in person at the Members' Meeting considering the amendment, may express their approval in writing, by proxy, provided such proxy vote is delivered to the Secretary prior to the Members' Meeting.
- 11.5 Certification. A copy of each amendment shall be certified by the Secretary of the State of Florida, and be recorded in the Public Records of Sarasota County, Florida.


