The Articles of Incorporation are amended as follows:

Article III is hereby deleted and replaced with the following provisions:

- III. The Corporation is created and shall be operated exclusively for charitable, religious, scientific, literary or educational purposes (hereinafter also referred to as "charitable activities"), including the following purposes:
- (a) To conduct and maintain a House of Worship in accordance with orthodox Jewish custom and traditions;
- (b) To promote and increase interest in the study of the Torah, by maintaining classes for the teaching of the customs, traditions and mode of worship of the orthodox Jewish faith;
- (c) To instill in its members and others of the Orthodox Jewish faith a reverence for the Almighty, a respect for persons of the Jewish faith and to create in its members an affinity for community service;
- (d) To aid and assist worthy indigent members of the corporation with loans and other kinds of support;
- (e) to buy, lease and otherwise acquire and to sell, lease and mortgage such personal property and real property as shall be necessary to further the purposes of the Corporation;
- (f) To perform any acts, including the raising of funds, necessary or incidental to carrying out any of the foregoing purposes; and
- (g) To do all things necessary to the accomplishment of the foregoing purposes and if the Directors so decide, to associate itself with persons and organizations desiring to assist in the effectuation of the purposes herein set forth.
