ARTICLES OF INCORPORATION
OF

IGLESIAS DE ALCANCE MISIONERO INC., MINISTERIO INTERNACIONAL

a non-profit organization

ARTICLE ONE

The name of this corporation is Iglesias De Alcance Misionero, Inc., Ministerio Internacional.

ARTICLE TWO

The initial principal place of business and mailing address of this corporation shall be 6040 SW 23rd Street, Miramar, Florida 33023

ARTICLE THREE

The period of the Corporation's duration is perpetual.

ARTICLE FOUR

1. The Corporation is organized following the Florida Non-Profit Corporation Act and does not contemplate pecuniary gain or profit. The general purpose of this non-for profit corporation (Church) is exclusively, charitable, educational, social and religious within the meaning of section 501 (C) (3), of the Internal Revenue Code of 1986, or corresponding provision of any future United States Internal Revenue law. The purpose of this organization is to help the underprivileged within the community. To receive and maintain real or personal property, or both, and subject to the restrictions and limitations hereinafter set forth. To use and apply the whole or any part of the income therefrom and the principal thereof exclusively for charitable, literary, social and religious purposes. Either directly or by contributions to organizations that qualify as exempt organizations under section 501 (C)(3) of the Internal Revenue code and regulations issued pursuant thereto as they now exist or as they may hereafter be amended.

2. No part of the net earnings of the Corporation shall inure to the benefit of any director/officer of the corporation, or any private individual. Except that reasonable compensation may be paid for services rendered to or for the corporation effecting one or more of its purposes. No director/officer or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the corporation. No part of the activities of the corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation. The corporation shall not participate in, or intervene in (including the publication or distribution of statements) any political campaign on behalf of any candidate for public office.

3. Upon the dissolution of the corporation the assets of the corporation shall be distributed exclusively to charitable organizations which would then qualify under the provisions of Section 501 (C)(3) of the Internal Revenue Code of 1986, or corresponding section of any future federal tax code, or shall be distributed to the Federal, State or local government for public purpose.

ARTICLE FIVE

The corporation shall not have any shares of capital stock following Section 617.0202, Florida Statutes.

ARTICLE SIX
