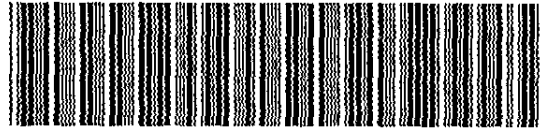

ARTICLES OF INCORPORATION

OF

**Eglise Evangelique de la Divinite Chretienne, Inc.**

ARTICLE I - DURATION

The name of this corporation shall be: **Eglise Evangelique de la Divinite Chretienne, Inc.**

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

The corporation is a not for profit corporation, organized specifically and primarily to solícite, collect, accumulate, administer, receive and maintain real and personal property, or both, in whatever form, including cash funds from public and private sources, and, subject to the restrictions and limitations hereinafter set forth: to use and apply the whole or any part of the income there from, and the principal thereof, exclusively for religious, charitable, or religious education purposes either directly or by contributions to organizations that qualify as exempt organizations under section 501 (c)(3) of the Internal Revenue code and the regulations issued pursuant thereto as they now exist or as they may hereafter be amended.

- (a) the general purpose for which this corporation is formed is to operate exclusively for such religious, charitable and education purposes as will qualify it as an exempt organization under section 501 (c) (3) of the Internal Revenue Code of 1986 or corresponding provisions of any subsequent federal tax

- (b) This Corporation shall not, as a substantial parts of its activities, carry on propaganda or otherwise attempt to influence legislation; nor shall it participate or intervene by publication or distribution of any statements or otherwise, in any political campaign on behalf of any candidate for public office.

#### ARTICLE IV – ELECTION OF DIRECTORS

The manner of election of directors is as stated in the by laws of the corporation.

#### ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT

The principal office of the corporation shall be the address of the registered agent of the corporation, whose name and address is:

#### ARTICLE VI – INITIAL BOARD OF DIRCTORS

The initial board of Directors shall consist of (3) members. The number of directors may be increased from time to time by a bylaw duly adopted pursuant to the laws of this corporation, but may never be less than three.

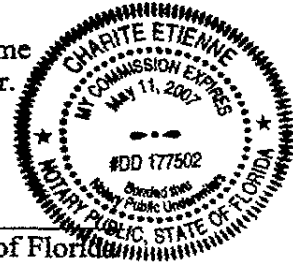
