ARTICLE II.


This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Nonprofit public Benefit Corporation Law for charitable and educational purposes. To establish structured support services for homeless and economically disadvantaged individuals, families and juvenile to a life of self-sufficiency. The program shall consist of but not limited to: Seminars, Workshops, Childcare, Outreach Advocacy Programs for the youth At Risk, Homeless, Housing for the Aged, Employment, Literacy, Counseling, Temporary Shelter, Teenage Pregnancy, Job Placement, and Acquisition, Substance Abuse Awareness and Prevention, Tutoring, AIDS Awareness, Elderly Care, After School, Summer, and other programs to aid those in need.

ARTICLE III.

The duration of this corporation shall be perpetual, no stock, and shall have no members.

ARTICLE IV.

ARTICLE VII.


